Clover Grown for Seed	Lesser Clover Weevil	1 1/3 lbs. (1 lbs ai)	Apply in a minimum of 10 gals. Of water by ground equipment (20 gals. For dense stands) or 5 gals. of water by aircraft. Consult your local farm advisor regarding the proper timing of application. Larvae should be sprayed when they are actively feeding. For application by irrigation systems, apply specified dosage per acre.

- Do not apply more than once per season.
- Caution must be exercised in irrigation waters with a pH greater than 7. If the irrigation cycle will last longer than 8 hours and the Imidan 70-W is premixed in the supply tank, the tank mix must be buffered to a pH of 6 or lower.
- Do not apply when bees are present.
- Do not allow the treated clover seed crop to be grazed.
- Do not cut the treated clover seed crop for hay or forage during the year that the crop is treated.
- Do not use with latex or pineolene-based adjuvants or any agricultural sticker or extender.
- All clover seed treated with Imidan 70-W must be tagged at the processing plants, "NOT FOR HUMAN OR ANIMAL CONSUMPTION". It shall be the grower's responsibility to notify the seed processing plant of any seed treated with Imidan 70-W.
