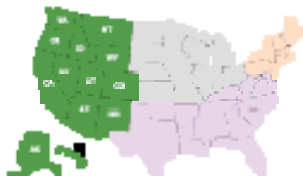

China Food Ingredients Inbound Buying Mission

This will be an excellent opportunity for companies to participate in the rapidly growing Chinese ingredients market.

China is the fifth largest export market worldwide for U.S. food ingredients. In 2007 US exports of food ingredients to China were \$292 million, a growth of 58% over the previous year. Food safety issues make high quality US ingredients more attractive than ever in China.

WUSATA, in conjunction with our contractor in China, will recruit buyers/importers from food processors to come to Washington, Idaho & Nevada. Participating buyers will meet with food ingredient suppliers in each state to develop contacts, learn about ingredient items that will meet their food production demands and discuss other issues relevant to importing products.

Suitable products include, but are not limited to:

Fats and oils, sweeteners, shelled nuts, flavorings, thickeners, starches, dairy ingredients, baking inputs, protein concentrates, potato products, cereal flours.

Products must be at least 50% U.S. agricultural origin by weight, excluding added water and packaging.

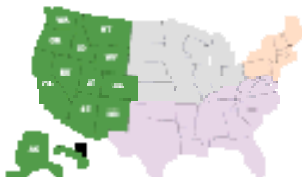
